Studio B – Garage Loading Instructions

The garage has 8ft height restrictions for clearance 6'8".

Access Studio B from the Garage; the drive-thru doorway is 9'4" wide by 6'7" tall.

There are (3) sets of load-in doors. Set 1 is 5'10.5" wide by 6'5" tall. Set 2 is 5'10.5" wide by 6'9" tall. Set 3 is 7'10" wide by 6'9" tall.

On all sets of doors, you lose 4"-6" of width due to the panic bars that open each set, as well as 2" of height due to the hinges attached to the top of each set.
